



# COVID-19: JUSTICE FOR EVERY CHILD

## ACTION PACK



**The coronavirus (COVID-19) pandemic has turned the world upside down, exposing the many inequalities that the world's most marginalised children are already facing.**

The leaders of the world's richest countries have made commitments of at least \$5 trillion to protect private businesses and economies, but 100 Million believes that protecting children should be a priority for every government – because they will suffer the most during the pandemic and in its aftermath.

As young people, we must stand together and demand that \$1 trillion – equivalent to 20% of government funds committed to the coronavirus recovery – should be dedicated to supporting the needs of the 20% most marginalised and excluded children and their families.

**This action pack explains 100 Million's global campaign on COVID-19, and how you can take action in support of it. Whether you live in a rich country or you belong to the most marginalised groups, we all can play a part in this campaign, and this pack explains how.**

### WHAT'S THE PROBLEM?

**As COVID-19 spreads across the world, nobody will feel the worst of its impact as painfully as the world's most marginalised young people.**

Children living in hard-to-reach villages, children in informal 'slum' settlements, children forced to work, children on the move – all of them and more will experience both immediate and longer-term suffering if the world does not act now.

In richer countries, families can stay at home and stock up on food, but millions of poorer children have no means to do the same. Nearly one in every five children in the world lives on \$2 a day or less, many of them in informal settlements too crowded to isolate, or living with underlying health conditions that put them at risk if they contract the virus. If the food supply is affected, or their adult family members cannot work, they will go hungry and soon starve.

In previous crises children and young people have paid the highest price when countries try to recover, because governments pay for their debts and bailouts by deprioritising investment in essential rights including children's education, health and nutrition.

As the economic impact of the pandemic has hit every country, governments have pledged trillions of dollars to help sustain economies and protect jobs and industries. However, very few commitments have been made to address the specific and urgent challenges being faced by children and young people.

**If decision-makers don't prioritise children and young people in their COVID-19 responses, they risk violating the fundamental rights of a whole generation, and undoing decades of progress towards eradicating extreme poverty, conflict and exploitation.**

# WHAT MUST HAPPEN - OUR CALL TO DECISION-MAKERS

World leaders must ensure \$1 trillion – equivalent to 20% of the global response funding – goes towards protecting the most vulnerable children and their families. Everyone must be included in the COVID-19 response and protected from the immediate and longer-term impacts of the pandemic, and none more so than the world's most vulnerable children.

We're calling on decision-makers to use this crisis as an important opportunity to address the existing inequalities which have excluded and marginalised children and young people for decades.

This will require commitment from all decision-makers from every country, rich and poor, to act urgently and boldly to ensure a sustainable and equitable recovery from this crisis for **everyone**.

## RICH COUNTRIES

Rich governments must commit to the following:

- Global funding to support the families of the nearly 20% of children around the world who live on less than \$2 a day.
- Making sure companies and businesses are paying their fair share towards supporting these families through paying their taxes and respecting human rights in their business practices.


The governments of these countries have an important role to play in delivering global justice.

As they control the majority of global trade and overseas aid funding, they have influence over how much money is shared with poorer countries and to whom within those countries these funds are allocated.

We've outlined the benefits that these actions could deliver to the world's poorest families on pages 5 and 6.



In the wake of the pandemic, children may be more likely to drop out of education and be forced to work in order to make up for the income lost when their carers could not work during national lockdowns.



Families risk being trapped in poverty for years and children's futures will be lost if their rights aren't prioritised by their governments.

## COUNTRIES WITH THE WORLD'S MOST MARGINALISED CHILDREN

Governments must ensure that marginalised and vulnerable children and their families receive their fair share of any response to COVID-19.

This means giving them a higher allocation to address the imbalance that has already long existed.

What this should look like in practice:

- Ensuring sufficient emergency healthcare services
- Maintaining or providing reliable clean water
- Protecting the supply of food
- Providing financial support to families with no income
- Considering the particular needs of those who don't have the means to self-isolate
- Supporting, not negatively targeting, marginalised communities and making sure that there is no risk to their lives from food and income insecurity.

# HOW YOU CAN ACT: HANDS UP FOR THE 1 IN 5

We want every decision-maker around the world to hear our call for justice, so we need YOU to help raise the profile.

Our campaign icon is a hand with a coloured thumb to represent the 1/5 (20%) most marginalised children who must be prioritised by governments and decision-makers. There are 4 simple steps you can take to support the campaign and we've laid out all you need to know on the next few pages:

## STEP 1: SIGN AND SHARE THE PETITION

The first step is to officially add your voice to our collective demand for change and sign the petition calling on decision-makers to protect the world's most vulnerable children. ## STEP 2: CREATE YOUR IMAGE

How you wish to create your version of the thumb image is up to you. You can simply colour in your thumb with whatever you have available — pen, paint, makeup, mud, chalk, or coal dust, for example. Or you can create your own poster by drawing around your hand or covering your hand in paint and pressing it onto the paper — much more fun!

### IF YOU'VE CREATED A DRAWING/POSTER:

- Display it visibly in your window or on an outside wall of your home to raise awareness of the campaign with your neighbours.
- Take a selfie of yourself and share it on social media
- Send your picture by post to your decision-maker along with a hand-written letter (using our template to help you).



## STEP 4: WRITE A LETTER TO YOUR DECISION-MAKER

**One of the most powerful things you can do to support this campaign is to contact your local decision-maker and call upon them to represent your views and champion this issue.**

If they receive enough pressure from people like you, they will feel compelled to influence your national government to listen to our demands and prioritise the most marginalised 20% in their COVID-19 response.

We have included two template letters to help you, including the key demands agreed by representative youth leaders from around the world. One is aimed at decision-makers in high-income countries and the other for those in lower-income countries that are home to some of the world's most marginalised children.

### TEMPLATE LETTER: HIGH-INCOME COUNTRIES

I believe world leaders must ensure 20% of the global response funding goes to protect the most vulnerable children and their families.

Until the virus is defeated everywhere it won't be defeated anywhere. Everyone must be included in the COVID-19 response and protected from the immediate and longer-term impacts of the pandemic, and none more so than the world's most vulnerable children.

I stand together with millions of young people to demand justice for all and I wish to receive a reply from you detailing your commitment to the most marginalised children.

## TEMPLATE LETTER: LOWER-INCOME COUNTRIES

Dear [Insert Name],

As a young person living within your constituency, I demand immediate action to prevent a child rights disaster happening in [your country] as a result of COVID-19.

In richer countries, families can stay at home and stock up on food, but for many families here in [your country], this is not possible. For example, communities that are too crowded to isolate, those without access to adequate sanitation or families that rely on adult daily-wage labourers to buy food and water. [insert any specific examples or names of marginalised communities you know of in your country. Make sure you respect individuals' personal situations by not sharing other people's identifiable information without their consent.]

As governments are allocating resources to the COVID-19 response I am asking that marginalised and vulnerable children and their families receive their fair share in [your country]'s plan. This must include ensuring sufficient emergency healthcare services, reliable clear water, the supply of food and where necessary financial support for families with no income.

These children and their families were already facing gross injustices before COVID-19, if we do not prioritise their protection during this crisis they will experience further suffering, both immediately and longer-term. We must support, not negatively target, marginalised communities during this time. Until the virus is defeated everywhere it won't be defeated anywhere.

I stand together with millions of young people who are also demanding justice for all and I wish to receive a reply from you detailing your commitment to the most marginalised children in [your country].

Once you've written it, you can send it by post or email, along with a copy of your thumb image, if possible, and reach out to them by social media to request a response.

# WHAT COULD BE ACHIEVED IF WE SUCCEED?

By standing and working together, we could prevent a child rights disaster happening during and after the COVID-19 pandemic.

Over \$5 trillion has been committed by wealthy governments to help bailout companies and economies. While some of the amounts being offered to companies are loans, the fact is that never before has so much money been offered in response to a global crisis.

If our leaders respond to our demands for \$1 trillion for the most vulnerable 20% of children worldwide – equivalent of a 20% share of the \$5 trillion for businesses – the futures for millions of children could be transformed.

## WHAT THIS \$1 TRILLION IN GLOBAL RESPONSE FUNDING COULD PAY FOR:

Over \$5 trillion has been committed by wealthy governments to bailout companies and economies. While some of this amount is in loans, never before has so much money been offered in response to a global crisis.

If our leaders respond to our demands for \$1 trillion – equivalent to 20% of this economic response – for the most vulnerable 20% of children worldwide, the futures for millions of children could be transformed. For example:

1. The UN's Global Humanitarian Response Appeal, the Global Alliance for Vaccinations and Immunisations (GAVI) and future WHO COVID-19 appeals could be fully funded, helping ensure the most vulnerable children are protected. = **\$11 BILLION**
2. If two years of all external debt payments due from the governments of low-income countries in 2020 and 2021 are cancelled, the funds could protect their vulnerable citizens. = **\$50.4 BILLION**
3. Closing the financing gap for the Sustainable Development Goal on health in low- and lower-middle-income countries by 2030. = **\$523 BILLION**
4. The Sustainable Development Goal on water and sanitation could be achieved for the next two years – this is critical for protection from COVID-19. = **\$228 BILLION**
5. For two years, we could cover the shortfall in financing to ensure every child gets 12 full years of education, helping to stop the spread of COVID-19. Marginalised children would be able to go to schools when they reopen, preventing a generation lost to child labour. = **\$78 BILLION**
6. We could create a new global children's social protection fund, to ensure no child is forced to work or go hungry – with \$10 billion per year to 2030. = **\$110 BILLION**
